

PENGARUH DANA PENGUATAN MODAL TERHADAP PENDAPATAN USAHA MIKRO KECIL DAN MENEGAH DI KABUPATEN SLEMAN

Penelitian ini bertujuan untuk mengetahui : (1) Pengaruh Dana Penguatan Modal Terhadap Pendapatan Usaha Mikro Kecil dan Menengah di Kabupaten Sleman (2) Berapa Persen Pengaruh Dana Penguatan Modal Terhadap Pendapatan Usaha Mikro Kecil dan Menengah di Kabupaten Sleman. Penelitian ini dilakukan di Badan Keuangan dan Aset Daerah Kabupaten Sleman pada bulan April – Mei. Metode penelitian yang digunakan menggunakan bantuan aplikasi olah data SPSS versi 18. Variabel independen dalam penelitian ini adalah dana penguatan modal, sedangkan variabel dependennya adalah pendapatan usaha mikro kecil dan menengah. Data yang dikumpulkan dengan cara melaksanakan magang dan wawancara. Penelitian ini menggunakan regresi linier sederhana taraf signifikan 5%. Berdasarkan hasil penelitian diketahui bahwa penerimaan dana penguatan modal berpengaruh terhadap pendapatan usaha mikro kecil dan menengah. Hal ini didasarkan atas hasil analisis menggunakan SPSS, perhitungan parsialnya menunjukkan t hitung $>$ t tabel ($6,809 > 2,0796$) dan signifikansi $0,000 <$ α ($0,05$). Jadi dapat disimpulkan bahwa terdapat pengaruh yang cukup parsial dari penerimaan dana penguatan modal terhadap pendapatan usaha mikro kecil dan menengah di Kabupaten Sleman. Besarnya kontribusi atau sumbangan penerimaan dana penguatan modal terhadap pendapatan usaha mikro kecil dan menengah ditunjukkan dengan besarnya R Square sebesar 0,688. Artinya adalah bahwa sumbangan pengaruh dana penguatan modal terhadap pendapatan usaha mikro kecil dan menengah adalah sebesar 68,8% dan sisanya sebesar 31,2% tidak dibahas dalam penelitian ini.

*THE EFFECT OF CAPITAL STRENGTHENING FUNDS ON THE INCOME OF
MICRO, SMALL AND MEDIUM ENTERPRISES IN SLEMAN REGENCY*

This study aimed to find out: (1) The Effect of Capital Strengthening Funds on Micro, Small and Medium Enterprises in Sleman Regency (2) the Percentage of the Effect of Capital Strengthening Funds on Micro, Small and Medium Enterprises in Sleman Regency. This research was conducted at the Regional Financial and Asset Agency of Sleman Regency in April - May. The research method used SPSS data processing application version 18. The independent variable in this study was capital strengthening funds, while the dependent variable was the income of small and medium micro businesses. Data were collected by conducting internships and interviews. This study used simple linear regression of a significant level of 5%. Based on the results of the study, it was identified that the acceptance of capital strengthening funds had an effect on the income of small and medium micro businesses. This was based on the results of the analysis using SPSS, the partial calculation showed $t_{count} > t_{table}$ ($6.809 > 2.0796$) and the significance of $0.000 < \alpha (0.05)$. So it could be concluded that there was a fairly partial influence of the receipt of funds to strengthen capital to the income of small and medium micro businesses in Sleman Regency. The amount of contribution or contribution of capital strengthening fund receipts to the income of small and medium micro businesses was indicated by the amount of R Square of 0.688. The meaning was that the contribution of capital strengthening funds to the income of small and medium micro enterprises was 68.8% and the remaining 31.2% was not discussed in this study.
